RESOLUTION OFFERED BY THE INTERGOVERNMENTAL/REDISTRICTING COMMITTEE

RE: ADOPTION OF FOREST COUNTY SUPERVISORY DISTRICT PLAN

RESOLVED by the Board of Supervisors of Forest County, Wisconsin, That

WHEREAS, pursuant to Wisconsin Statutes Section 59.10 (3)(b)(2), Forest County is required to submit a final supervisory district plan by dividing the county into districts by the number of supervisors with each district substantially equal in population as set forth in the 2020 Federal Census of Population; and

WHEREAS, on October 19, 2021 the Forest County Board of Supervisors considered a tentative plan for establishing county Supervisory districts within Forest County; and

WHEREAS, public hearings were held at which hearing comments were solicited from public and from various municipalities concerning the proposed tentative plan; and

WHEREAS, at the conclusion of the public hearing, a tentative plan was adopted and copies of said plan were transmitted to each municipality within Forest County; and

WHEREAS, the municipalities within Forest County have adjusted their wards according to the tentative plan adopted by the Forest County Board of Supervisors; and

WHEREAS, public hearings were held, at which time the Intergovernmental/Redistricting Committee considered any objection or suggestions from the various municipalities or concerned citizens with regard to the plan presently before the Board; and

WHEREAS, any amendments to said plan have been incorporated into the final Supervisory District Plan.

NOW, THEREFORE, BE IT RESOLVED by the Forest County Board of Supervisors that the Forest County Supervisory District Plan, which is on file with the County Clerk, including any amendments made thereto, be and the same is hereby adopted.

BE IT FURTHER RESOLVED that the County Board Chairperson is hereby authorized and directed to file a copy of this plan with the Secretary of State.
