Resolution offered by the Zoning Committee:

WHEREAS, Forest County previously adopted Sanitary Ordinance Section 24.13 entitled Non-Plumbing Sanitary System which is commonly referred to as the “Forest County Sanitary Ordinance;” and

WHEREAS, the Zoning Committee has reviewed the Forest County Sanitary Ordinance and believes it is in the County’s best interest to amend the existing ordinance; and

WHEREAS, said amendment has been approved by the Department of Commerce, Safety and Professional Services Division; and

WHEREAS, the changes and amendments to the existing Forest County Sanitary Ordinances are as set forth as follows: (The amendments set forth below are underlined.)

Page 8, Section 24.13, entitled Non-Plumbing Sanitary Systems, shall now be entitled Alternate Sanitary Systems Allowed. The amendments to this section shall read as follows:

4. *RV Transfer Tanks*

1. *RV Transfer (holding tanks) are allowed on properties where an RV, Motorhome, or Camper Trailer are permitted. The tank size shall meet the following criteria:*
 - a. *Minimum size of 250 gallons.*
 - b. *Shall be above ground only.*
 - c. *Inspection, servicing and maintenance openings shall terminate with a means that prevent deleterious materials.*
 - d. *Covers for openings larger than 8 inches in diameter shall be provided with locking devices or other effective measures to prevent unauthorized*

access.

e. Minimum setback as SPS 383.43-1 of 25 feet from

a well.

f. Minimum setback of 10 feet from a property line.

Permit will require a servicing contract.

g. Permit will require servicing contract."

NOW, THEREFORE, BE IT RESOLVED, that the Forest County Board of Supervisors does hereby adopt the changes to the Forest County Sanitary Ordinance as set forth herein; and

BE IT FINALLY RESOLVED, that a copy of this ordinance immediately be made available to the public on the County's website and at the Forest County Zoning Office.
