## DISCUSS ACTION TAKEN BY LAND CONSERVATION COMMITTEE FOR THE ADMINISTRATOR

Motion by Albrecht to back pay the Land & Water Resources Administrator for working on the LCC grant from April 1<sup>st</sup> to April 15<sup>th</sup>, seconded by Collins. All present voting AYE. Motion carried.

DISCUSS FLEX TIME FOR LAND & WATER RESOURCES ADMINISTRATOR Motion by Albrecht to not allow flex time for department heads, seconded by Dailey. All present voting AYE. Motion carried.

DISCUSS HEALTH DEPARTMENT JOB DESCRIPTIONS AND JOB OPENING Motion by Dailey to allow Public Health Director to post the position as needed and to approve the job description for the Community Health Specialist, seconded by Collins. All present voting AYE. Motion carried.

### DISCUSS SICK LEAVE LANGUAGE IN THE EMPLOYEE HANDBOOK

Motion by Albrecht to include the following language in the Employee Handbook under sick leave benefits:

Or any employee who retires shall have all the unused sick leave remaining in his/her account shall be converted to a monetary value at the daily rate then in effect, and said amount shall be used to pay for health insurance coverage for both the employee and his/her dependents then being carried by the County, or for the supplement to Medicare, if over sixty-five (65) until such time the employee and his/her spouse are deceased or the fund is depleted. The full premium payment shall be paid out of the account and the County shall not be obligated to contribute on a percentage basis as currently done for those employees who are on the payroll, seconded by Dailey. All present voting AYE. Motion carried.

#### CLOSED SESSION

Motion by Dailey to adjourn into closed session pursuant to Wis. Stat §19.82 (1) to meet for the purpose of collective bargaining under subch. I, IV, V, or VI of Ch. 111; Wis. Stat. § 19.85 (e) deliberating or negotiating the purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reason require a closed session. This closed session relates to discussion on successor collective bargaining agreement. –Forest County Deputy Sheriff's Association and Wis. Stat. §19.85 (g) conferring with legal counsel for the governmental body who is rendering oral or written advice concerning strategy to be adopted by the body with respect to litigation in which it is or is likely to become involved, seconded by Collins. Roll call vote Albrecht AYE, Collins AYE, Dailey AYE, Lukas AYE, Millan AYE, Shaffer AYE. Motion carried.
