The committee was initially formed to take care of a grant that was received and taking care of the receipts. The park is linked to the Forestry Committee so they would like it to all flow through that department. There will be an MOU drawn up by the County attorney between the Forestry Committee and WORPVI. Don LeMaster would like the MOU to state that WORPVI is to bring all presentations to public hearings so that all people are aware of what is happening.

DISCUSS SETTING UP A TOUR OF PROPOSED SITE FOR COUNTY BOARD MEMBERS

Sommer wanted to make it clear to all in attendance that the board has not approved this park yet. LeMaster would also like Millan to check into the revenue cap and whether a referendum is needed if the county exceeds the revenue to continue with the project.
