- 3. How are donations recorded? What is the requesting process? Are thank you letters sent out to those that donate? How much and what was taken in in 2014?
- 4. How many children attended the free ride night of the fair in 2014?

5. How is the financial statements prepared? Why are the complete ledgers not turned into the county treasurer's office? (Examples: How much beer tent brought in (Friday, Saturday)? Starting cash on hand?, etc...)

Dailey made a motion that the donation from the Mole Lake Sokaogon Chippewa Community be applied to the 2016 Fair. Berg seconded the motion. The motion carried.

Bucky Dailey made a motion to address Agenda Items 5-9 at the next meeting. Melinda Otto seconded the motion. The motion carried.
