2015 WDVA/CVSO GRANT

The grant through the WDVA that the VSO applied for was received in the amount of \$8,500 on June 26, 2015. There are some changes that are going to be made to this grant next year. The VSO will keep the Committee & Commission updated on what those changes will be when he learns of them.

NACVSO ACCREDITATION INFO

The VSO completed a course/training from June 1-5. It was for the National County Veterans Service Organization. It allows the VSO to be accredited through the DAV and other organizations that serve Veterans throughout the USA.

RELEASE OF NAMES & ADDRESSES INFO - RECENTLY DISCHARGED

The VSO sent a letter to Veterans' Affairs in Washington D.C. requesting names and address of Veterans that have been discharged and have come back to Forest County that the VSO does not know about, so he can reach out to them and let them know what benefits he/she is eligible for. They wrote back to the VSO and they are going to send the VOS labels from the last couple years and will continue to send the VSO update address labels every six months.

SPECIAL MILITARY SOCIAL SECURITY RATES

For the most part most Veterans who are receiving social security are already receiving this benefit. It still is something Veterans should probably check to verify that he/she is receiving this benefit.

DONATION UPDATES

Jeff Kau – Subway donated \$100. Three families donated \$65 in memory of Richard Pheiffer.

COMMISSION TRAVEL & MEETING REIMBURSEMENT

The VSO is going to pay the Commission Travel & Meeting Reimbursement out to the members.
