Meeting called to order by Chairman LeMaster. Motion by Chaney, seconded by Campbell to approve the agenda as read. All voting ave, motion carried. Motion by DeHart, seconded by Connors to approve the minutes from the September 8, 2015 meeting. All voting aye, motion carried. Ziolkowski requested approval to pay an invoice in the amount of \$3,124.00 from MSA Professionals for reengineering a trail design to cross Highway 8 for the ATV trail. Motion by Sommer, seconded by Chaney to approve paying the bill in the amount of \$3,124.00 from MSA. All voting ave, motion carried. Motion by Connors, seconded by DeHart to go into Closed Session in accordance with WI Statute 19.85 (1) (e) "Deliberating or negotiating purchasing of public properties, the investing of public funds, or conducting other specified public business, whenever competitive or bargaining reasons require a closed session. A roll call vote was taken: Connors, aye; Chaney, aye; Sommer, aye; Campbell, aye; DeHart, aye; LeMaster, aye. All voting aye, motion carried. CLOSED SESSION. Motion by Connors, seconded by Campbell to return to OPEN SESSION. All voting aye, motion carried. OPEN SESSION. Grant Applications. All voting aye, motion carried. The Committee also discussed obtaining other loans in addition to Project Loans to allow the County to acquire larger blocks of forest land and expedite the acquisition process. The Committee agreed that this is a beneficial, cost effective program for Forest County which is generating additional revenue to offset taxes, creating jobs for local residents, providing raw materials for local mills and providing additional recreational opportunities for the public. Ziolkowski and DNR representatives were asked to present this information to the full County Board. Millan agreed to contact Jason Hilger to obtain additional information on additional acquisition loans. Motion by Chaney, seconded by Campbell to approve sending a resolution to the County Board to support Good Neighbor Authority. All voting aye, motion carried. Motion by Chaney seconded by DeHart to approve sending a resolution to the full County Board to request that the DNR allow local businesses to continue the traditional method of registering deer not the current electronic method. All voting aye, motion carried. Next meeting day is November 16, 2015 at 4:00 p.m. in the County Board Room. There being no further business at this time motion by DeHart seconded by Sommer to adjourn. All voting aye, meeting adjourned.
