APPROVE AMENDED AGENDA

Motion by Collins to approve the amended agenda as presented, seconded by Chaney. All present voting AYE. Motion carried.

APPROVE MINUTES FROM THE JUNE 8, 2016 FINANCE & PUBLIC PORPERTY MEETING

Motion by Lukas to approve the minutes of the June 8, 2016 Finance & Public Property Meeting seconded by Connors. All present voting AYE. Motion carried.

APPROVE MINUTES FROM THE JUNE 20, 2016 PERSONNEL MEETING

Motion by Collins to approve the minutes from the June 20, 2016 Personnel Meeting seconded by Chaney. All present voting AYE. Motion carried.

CLOSED SESSION

Motion by Marvin to send a resolution to amend the budget in the amount of \$100,000 to appropriate funds for repairs and maintenance to the Courthouse & Jail, and Courthouse Security, seconded by Connors. All in favor voting AYE. Motion carried.

The wage increase is due to an increase of state funding for reimbursed wages up to 85% of the Highway Patrol Supervisor's wage, to begin with the July 31, 2016 payroll date, seconded by Connors. All present voting AYE. Motion carried.

DISCUSSION AND POSSIBLE APPROVAL OF A RESOLUTION TO AMEND THE SMOKING POLICY IN THE EMPLOYEE HANDBOOK

Motion by Collins, to send a resolution to the full county board in August amending the smoking policy in the Employee Handbook, seconded by Chaney. All present voting AYE. Motion carried.

DISCUSSION AND POSSIBLE APPROVAL OF BIDS ON LAWNMOWER FOR MAINTENANCE

The bids were looked at and discussed and a question was raised on two of the lawnmowers which will be addressed with Maintenance. The final decision on the purchase of the lawnmower will be at the next Personnel & Finance Meeting on August 1st, 2016.
