Alvin –Total number of voters 101. There were some voters in the poll book that were not assigned a voter number.

Argonne– Total number of voters 275. Number of ballots cast on the inspectors statement should read 275 not 274, corrected in red. Argonne reported one (1) vote for Monica Morehead/Lamont Lily and zero (0) votes for Rocky Roque De La Fuente/Michael Steinberg, tally shows actual votes as: zero (0) votes for Monica Morehead/Lamont Lily and one (1) vote for Rocky Roque De La Fuente/Michael Steinberg

Armstrong Creek- Total number of voters 232. Total number of voters not on all three (3) tally sheets, corrected in red.

Blackwell- Total number of voters 59.

Caswell--Total number of voters 47. Memory device serial number and tamper evidence serial number missing from Inspectors Statement. Caswell reported zero (0) votes for United States Senator Scattering, zero (0) votes for Representative To The Assembly Dist#34 Scattering and zero (0) votes for District Attorney Scattering, tally shows actual votes as: one (1) vote for United States Senator Scattering, one (1) vote for Representative To The Assembly Dist#34 Scattering and two (2) votes for District Attorney Scattering

Town of Crandon– Total number of voters 332. Poll book shows duplicate voter numbers; 68, 231 and 265. One voter was not assigned a voter number.

Freedom- Total number of voters 225.

Hiles—Total number of voters 259. Voters are required to complete a new registration form anytime there is a name or address change. Making note in the poll book is not acceptable.

Laona- Total number of voters 605. Laona reported two (2) votes for District Attorney Scattering, tally shows actual votes as: three (3) votes for District Attorney Scattering.

Lincoln– Total number of voters 514. Lincoln reported one (1) vote for Evan McMullin/Nathan Johnson, President/Vice President, tally shows actual votes as: one (1) write in vote for Bernie Sanders/Evan McMullin, this vote would be considered a scattering as Bernie Sanders is not one of the registered write ins. This changes the count to zero (0) votes for Evan McMullin/Nathan Johnson, President/Vice President and three (3) votes for President/Vice President Scattering. Voters are required to complete a new registration form anytime there is a name or address change. Making note in the poll book is not acceptable.

Nashville-Ward 1 – Total number of voters 209. Nashville Ward 1 reported one (1) vote for President/Vice President scattering, tally shows actual vote as: one (1) under vote. Under votes should not be counted as scattering.

Nashville-Ward 2 – Total number of voters 158. Tally Sheets state total votes as 157, corrected in red. Voter identification number 114 was used twice.

Nashville-Ward 3 – Total number of voters 219. Nashville Ward 3 reported zero (0) votes for Jill Stein/Ajamu Baraka, President/Vice President, tally shows actual vote as: one (1) vote for Jill Stein/Ajamu Baraka, President/Vice President. Inspector statement shows 157 machine votes, tape from machine shows 158. Only 157 voters were recorded, the municipal board of canvassers was brought in to draw down one machine vote.
