The ADRC is primarily funded by State & Federal funds and Oneida County no longer wants to fund the up-front costs of the employees of the ADRC until the state reimburses them. The ADRC is asking that Forest County become the Fiscal Manager to take over the payroll that Oneida County does not want to do anymore, but the cost up-front for Forest County would be \$179,000.00. Oneida County will continue to do ADRC's expenses just not the payroll.
