Funds designated as Community Options Program funds for Forest County that are eligible to transfer to Children's Community Options Program will be transferred by the Department of Health Services; and Funds in the Forest County COP Risk Reserve, currently held by the Forest County Department of Social Services, at the close of calendar year 2017 will be transferred to a fund established by The Human Service Center in accordance with Wisconsin Statute 46.272 (13) (f) as the CCOP Risk Reserve. These funds will be earmarked specifically for services under Wisconsin Statute 46.272, Children's Community Options Program, and will be used only for eligible Forest County youth with the recommendation of the Department of Social Services; and

The Human Service Center, as CCOP lead agency for Forest County for 2018, will maximize the use of CCOP funds as match for the Children's Long Term Support Program in order to minimize the amount of County Tax Levy used to support that program and will provide monthly updates on the use of these funds to the Director of the Department of Social Services who will provide the reports to the Social Service Committee monthly.
