Cihasky explained that he and his team had interviews with the departments this week. There was discussion on space and security issues that need to be addressed. They explained the procedure and process of what they are doing and what comes next. A committee member addressed the obligation to fix problems now that will work with added projects

needed in the future with the main issues being the Jail and the Court system. There was also discussion on the current boiler system in the Courthouse.

DISCUSSION AND REVIEW OF SAMUEL'S GROUP-WENDEL CONTRACTS

Kurt Brenner from Samuel's Group and David Cihasky from Wendel were present to answer any questions with the contract. Kurt explained that the contracts are below the original amount that was approved for this portion of the project, which was \$200,000, they are around \$134,500. A survey should be completed & soil boring, with the elevation differences for the utilities for building & infrastructure. The contacts will be taken home for the committee members to go over and then put on the next committee meeting for possible approval.
