### WI DEPARTMENT OF HEALTH SERVICES HOUSING SEARCH UPDATE-PRESENTATION MICK CHASE

There was discussion about possible placement outside of the County temporarily, so that the offender is not released without supervision. Dennee displayed his concern on the current address that was being considered for the placement. He suggested that this committee was just formed and the courts need to give them the chance to look, they do not want to make fast decision. He thought there was need to slow down the process to give the committee a chance to make a good decision.

- a. Rental Properties- There is nothing available for rental properties within the 1500 feet.
- b. County Owned Properties- There are none currently available that meet the criteria.
- c. For Sale Properties- Dennee and Fannin went through the properties that were available and were able to narrow them down to nine (9). The committee will check into these remaining nine (9), and bring back what they find out about the properties for review at the next meeting.
