# 4. Short Report on FSFC Meeting – Tom Tallier:

The committee was informed of a tour that the FSFC is planning which will invite Federal and State officials to attend. Tallier will inform the Forestry Committee on the dates when they come available.

## 5. Update discussion and possible action on Veterans Memorial Park Improvements:

The committee was informed of that the Park would need 25 trees to plant this fall and that the Forestry and Parks Department would like to pursue various grants to make more improvements to the Park. Motion by Miller and seconded by Karl to purchase the 25 trees and pursue any available grants for the improvements of the park. All present voting aye, motion carried.

Wayne Daul addressed the committee on the plans to construct a warming hut on LMT 6. Motion by Miller and seconded by Campbell to approve the construction of a warming hut (approximately 14 x14) on the LMT 6 All members present voting aye, motion carried.

The committee was informed of the issues that were brought to the attention of the Forestry and Parks Department by the WI DNR. Motion by Dehart and seconded by Miller to pursue grants to repair bridges and hire a structural engineer to inspect bridges.

Motion by Dehart and seconded by Karl to pursue any new parcels that would be advantageous to the County. All members present voting aye, motion carried.
