APPROVE AMENDED AGENDA

Motion by Gretzinger to approve the amended agenda, second by Berg. All present voting AYE. Motion carried.

APPROVE MINUTES FROM THE AUGUST 20, 2018, JOINT PERSONNEL & FINANCE AND THE SEPTEMBER 17, 2018 FINANCE COMMITTEE MEETING Motion by Stamper to approve the minutes from the August 20, 2018, Personnel Meeting & Finance meeting, second by Chaney. All present voting AYE. Motion carried. Motion by Gretzinger to approve the minutes from the September 17, 2018 Finance Committee meeting, second by Lukas. All present voting AYE. Motion carried.

DISCUSSION AND POSSIBLE ACTION WITH JAIL ADMINISTRATOR ON JAIL/DISPATCHER WAGES

Josh Bradley (Jail Administrator), and John Dennee (Sheriff), were in with numbers from other counties to show how far behind the county is on wages and Josh worked on a tier system for employees to keep them here. The Clerk will take the tier system and work the numbers for the 2019 budget year to see the increase and bring it back to the next committee meeting for final decision.

DISCUSSION AND POSSIBLE ACTION ON RECOMMENDATION FROM THE FORESTRY COMMITTEE TO INCREASE THE ADMINISTRATIVE ASSISTANT WAGE

Motion by Gretzinger to increase the Administrative Assistant wage to \$18.00 per the Forestry Committee request, with a start date of the beginning of the next pay period, second by Stamper. All present voting AYE. Motion carried.

DISCUSSION AND POSSIBLE ACTION ON RECOMMENDATION FROM THE FORESTRY COMMITTEE TO INCREASE THE PARK MANAGER'S SALARY Motion by Stamper to increase the Park Manager's salary from \$12,000 to \$15,000, second by Gretzinger. All present voting AYE. Motion carried.

b. APPROVE APPOINTMENT OF AL MURRAY TO THE LAND INFORMATION OFFICER ON THE RECOMMENDATION OF THE LAND INFORMATION

Motion by Berg to appoint Al Murray to the Land Information Officer on the recommendation of the Land Information Committee, second by Stamper. All present voting AYE. Motion carried.

c. DISCUSS AND POSSIBLE APPROVAL OF RE-ORGANIZATION OF THE LAND INFORMATION TO CREATE A DEPARTMENT HEAD AND COMBINE THE LAND CONSERVATION AND LAND INFORMATION COMMITTEES RESOLUTION

Motion by Gretzinger to approve the resolution for re-organization and the combination of the committees for grant purposes, second by Stamper. All present voting AYE. Motion carried.

John Dennee asked about NEOGOV software and that he did not think this would apply to his department. The clerk explained that NEOGOV is software that the department heads worked on with Personnel to get put into place. It was explained that whenever department heads went to the Personnel for increases in wages for their employees they were asked for some back up to the request and this was put into place to help with that. The clerk also explained that if the departments did not want to use it they did not have to use it.

Motion by Chaney to update the wage for the Paving Foreman job description, second by Stamper. All present voting AYE. Motion carried.
