# DISCUSSION AND POSSIBLE ACTION ON HEALTH INSURANCE CHANGE FOR 2019

Motion by Lukas to renew the health insurance with Security Health for 2019, at a -.1% decrease in premium, adding a 20/40/60/25% cop-pay for prescriptions after the deductible is met, second by Gretzinger. All present voting AYE. Motion carried.

### DISCUSSION ON THE 2019 BUDGET

There were several adjustments to balance the budget, some including the Forestry purchasing a UTV with Variable Acreage money, removing the performance evaluation software, taking out the Outlay items from the Judge, Jail, Sheriff, and other departments and then funding the outlay items from the general fund. The revenues for the Tax deeding and Clerk of Court fees were increased and there was discussion about the Maintenance budget, which will be finalized at the October 11, meeting.
