PUBLIC COMMENT

Tom Vollmar from the Town of Nashville commented that he thought it would be good idea for the County to find a property and rent to the state.

Neal Schallock stated that there is a playground within 1500 feet of the home now being used as a rental. He also stated he felt that the property was sold illegally.

John Dennee informed the public that the committee's responsibility was not to check into any private contracts the property owner may have had.

Craig Schallock also stated he felt it would be a good idea for the County to find a place for these individuals. He felt it would be a good idea because everyone would know in advance, where they would be living.

Chris McGeshick wanted to know if the County planned on fighting the placement of another predator from another county. He also wanted to know how many more offenders were planned for release to Forest County. He also stated he thought it would be a good idea for the county governments to look into a property for this situation.

Mick Chase said at this time there are no offenders from Forest County at Sandridge.

Jill Kettlewell asked that she be put on record as against any placement of any sex offenders from other counties in Forest County.

Other members of the public spoke in consensus of a property that everyone was aware would house these offenders.

DISCUSSION AND POSSIBLE ACTION ON NEW SEX OFFENDERS BEING PLACED IN FOREST COUNTY

Motion by John Dennee to forward a resolution on to full County board against any further placement of 980 sex offenders from other Counties in Forest County, seconded by Fannin. Voting Aye, Dennee, Fannin, Anderson, Tallier, Payant and May. Mick Chase stated conflict of interest and abstained from voting. Motion passed.
