DISCUSSION AND POSSIBLE ACTION ON A RESOLUTION TO BE FORWARDED TO FULL COUNTY BOARD ON A CELL PHONE POLICY UPDATE TO THE EMPLOYEE HANDBOOK

Motion by Stamper to amend the handbook by resolution form to send to the full County Board, in reference to cell phone use,

Current language:

Employees whose job responsibilities include regular or occasional travel are expected to refrain from using a cell phone while driving. Safety must come before all other concerns. Regardless of the circumstances, including slow or stopped traffic, employees are strongly encouraged to pull off to the side of the road and safely stop the vehicle before placing or accepting a call. If acceptance of a call is unavoidable and pulling over is not an option, employees are expected to keep the call short, use hands-free options if available, refrain from discussion of complicated or emotional issues and keep eyes on the road. Special care should be taken in situations where there is traffic, inclement weather or the employee is driving in an unfamiliar area. Employees whose job responsibilities do not specifically include driving as an essential function but who are issued a cell phone for business use are also expected to abide by the provisions above.

Amended language:

Employees whose job responsibilities include regular or occasional travel are expected to refrain from using a cell phone while driving. Safety must come before all other concerns. Regardless of the circumstances, including slow or stopped traffic, employees must refrain from placing or accepting a call unless using a hands free device. When hands free devices are not available, employees are required to pull off to the side of the road and safely stop the vehicle before placing or accepting a call. When pulling off to the side of the road is not an option, employees are required to wait to place or accept a call until they are able to pull off the side of the road and safely stop the vehicle.

Employees whose job responsibilities do not specifically include driving as an essential function but who are issued a cell phone for business use are also expected to abide by the provisions above.

Second by Berg. All present voting AYE. Motion carried.

DISCUSSION AND POSSIBLE ACTION ON A RESOLUTION TO FORWARD TO FULL COUNTY BOARD ON AN UPDATE TO THE HOLIDAY SCHEDULE FOR THE COURTHOUSE TO INCLUDE THE DAY AFTER THANKSGIVING

Motion by Gretzinger to approve adding the extra holiday closing to the courthouse schedule for 2019 to be put in resolution form for the full County Board approval, second by Chaney. All present voting AYE. Motion carried.
