- 3. Review technology decisions with recommendation to the Finance Committee and County Board.
- 4. Insure the efficient and necessary use of County technology to render services to county departments and taxpayers.
- 5. Insure that adequate technology services are available to County Departments. Confer with them regarding the operation of their offices and/or departments.
- 6. Review the annual County technology outlay and maintenance budget. Recommend approval of such budget to Finance Committee and County Board as necessary.
- 7. Oversight for the Public Safety technology and associated wireless communications systems that interface with the dispatch functions supported by the County of Forest.
- 8. Oversight for the County fiber networks.
- 9. Oversight to the County community area network and resource sharing.
