An update on Land Information now available within GIS was given by Murray. New data in GIS includes all gravel pits, USFS data (roads, timber sales, property lines and corners), Infrastructure from WPS (electrical service by phase, natural gas service), broadband coverage, Zoning classes will be the next data mapped.
