- I. Welcome: Secretary Melinda Otto welcomed all and called the meeting to order at 2:59 pm. Introductions took place.

 - c) Forest County Job Center Update: Job Center is open two times a month with a steady traffic.

 - b) 2019 Looking Forward: Tallier spoke on the Gaming Compact and requested a letter of support from FCEDP. Bridges on the

trails were mentioned and efforts made to avoid closure, and plan is in place to restructure was discussed. Master-plan for recreational trails was discussed with a 10 year span. Lukas questioned if a grant writer was needed for the broadband expansion, Ferris mentioned the Potawatomi grant writers as a possible source. Discussion took place for opportunity within the Industrial Park improvements and investments. Ferris stated when we have the same mindset Forest County will project growth, as projected in the year-end report this is crucial to the community of Forest County. Good communication moving forward in 2019.
