CONDUCT CANVASS OF THE APRIL 2, 2019, SPRING ELECTION

Town of Alvin-Ward 1 – Total number of voters 67. No outstanding provisional ballots. Seven (7) absentees. Seven (7) EDRs. Inspectors' statement missing tamper evidence seal number for ballot bag and chief inspector initials. Tally sheet missing number of last vote on poll list.

Town of Argonne-Wards 1-3 – Total number of voters 97. No outstanding provisional ballots. Two (2) absentees. Five (5) EDRs.

Town of Armstrong Creek-Ward 1 – Total number of voters 218. No outstanding provisional ballots. Eight (8) absentees. Sixteen (16) EDRs.

Town of Blackwell-Ward 1 – Total number of voters 27. No outstanding provisional ballots. Six (6) absentees. Zero (0) EDRs. Voter presented picture of MyVote voter application, voter signed supplemental poll list, and because it was a late registration, it should have been noted on the inspectors' statement.

Town of Caswell-Ward 1 - Total number of voters 25. No outstanding provisional ballots. Two (2) absentees. Zero (0) EDRs. Tally sheet missing number of last vote on poll list.

Town of Crandon-Wards 1-3 – Total number of voters 117. No outstanding provisional ballots. Two (2) absentees. Three (3) EDRs. Statistics report was incomplete. Total number of EDRs on Inspectors' Statement said One (1), actual was Three (3) Tally sheet missing number of last vote on poll list. Pages #4 and #30 had signatures with no assigned voter #; page #53 of poll book had a voter with no signature. Voter #41 was assigned a second time on page #42 of poll book.

Town of Freedom-Ward 1 – Total number of voters 115. No outstanding provisional ballots. Nineteen (19) absentees. Zero (0) EDRs.

Town of Hiles- Ward 1 – Total number of voters 142. No outstanding provisional ballots. Nineteen (19) absentees. Two (2) EDRs. Tally sheet missing number of last vote on poll list

Town of Laona- Wards 1-3 - Total number of voters 305. No outstanding provisional ballots. Twenty-three (23) absentees. Thirteen (13) EDRs. Page #47 of poll book had a signature with no assigned voter #.

Town of Lincoln- Wards 1-3 – Total number of voters 288. No outstanding provisional ballots. Twenty-eight (28) absentees. Fifteen (15) EDRs. Top portion of statistics report incomplete. Inspectors' Statement missing memory device serial number and chief inspector initials. Total number of voters on inspectors' statement should be the total number of voters that voted in the election, not the number printed in poll list. Number of absentee voters on inspectors' statement was Thirty (30); actual is Twenty-eight (28) rejected absentees should not be included in this total.

Town of Nashville- Ward 1 – Total number of voters 95. No outstanding provisional ballots. Nine (9) absentees. Five (5) EDRs.

Town of Nashville- Ward 2 – Total number of voters 30. No outstanding provisional ballots. Zero (0) absentee. Two (2) EDRs. Voter #2 voted in wrong ward as an EDR, voter lives in ward 3.

Town of Nashville- Ward 3 – Total number of voters 91. No outstanding provisional ballots. Ten (10) absentees. Four (4) EDRs. DRE shows two (2) more votes than actual due to worker error, worker inadvertently cast two (2) blank ballots. Three (3) EDR reported, actual is Four (4) due to EDR error in Ward 2. Called in Town Clerk, we needed original poll book with signatures. Both County and Town poll books were missing voter #34, Town Clerk is sure poll workers skipped over #34 when assigning voter numbers.

Town of Popple River- Ward 1 – Total number of voters 14. No outstanding provisional ballots. Zero (0) Absentees. Zero (0) EDR. Inspectors' statement missing the tamper evidence seal number for ballot bag.

Town of Ross- Ward 1 – Total number of voters 35. No outstanding provisional ballots. Zero (0) absentees. Zero (0) EDRs. Tally sheet missing number of last vote on poll list.

Town of Wabeno- Wards 1-5 – Total number of voters 134. No outstanding provisional ballots. Six (6) absentees. Six (6) EDRs.

City of Crandon- Wards 1-4 – Total number of voters 309. No outstanding provisional ballots. Seventeen (17) absentees. Eleven (11) EDRs. Total number of EDRs on inspectors' statement stated one hundred sixteen (116); actual was eleven (11). Total number of absentee voters on inspectors' statement stated nineteen (19); actual was seventeen (17). Inspectors' statement missing number of votes cast on paper and DRE. Page #82 of poll book had a voter with no signature.

Evans made a motion to adjourn at 12:59 p.m., seconded by Matuszewski, all in favor motion carried.
