Dennee explained that he uses Wurtinger and Theune when he needs it, cost this year around \$1,000. Tallier talked with other counties around and found that Forest County IT is costing considerably less, and a lot of them are working with an employee and an outside contract organization. Nauncka explained that his contract does cover the Jail as well as the Highway, which he works with already. John explained that Marchant is being trained on the TRACS right now. The committee would like to see an overview of what the county has.
