APPROVE MINUTES FROM THE SEPTEMBER 11, 2019 MEETING

Motion by Burl to approve the minutes from the September 11, 2019 Risk Management meeting, second by Lukas. All present voting (AYE). Motion adopted.

PUBLIC COMMENT

Maintenance Supervisor, Rinehart informed the committee that the County has been getting violations in fire inspections, and one is for the ceiling tiles in the board room. They are a fire barrier and they are curling up causing them to be inefficient. They told Rinehart the tiles have to be replaced. This will be forwarded on to the Building committee.

The fire inspectors also told Rinehart there should be fire drills done in the buildings. There was a suggestion that Theune be present for the next meeting to discuss drills and the emergency app he had discussed with the committee.

Jacee Shepard suggested that there be lock down drills done as well.

Maintenance had a training with the elevator company on procedure to get people out of the elevator that are trapped and they will show the fire inspectors as well.

Rinehart informed the committee that Theune had the evacuation posters done and they were going to be putting them up soon.

DISCUSSION ON WORKERS COMPENSATION FLAT DIVIDEND AND SLIDER DIVIDEND FOR 2018

The Clerk showed the committee the amount of the slider dividend the County received for the 2018 plan year for Workers compensation in the amount of \$28,447.22, she also had a letter from the insurance company that showed the loss ratio for 2018 was above 75%, which caused that County not to receive the flat dividend of 10%.

DISCUSSION AND POSSIBLE ACTION ON VETERANS COMMITTEE RECOMMENDATION TO DESIGNATE TWO RESERVE SPOTS FOR VETERANS ACROSS FROM THE DA'S OFFICE

The Veteran Service Officer was in and explained to the committee that he is only looking for one parking space and that the space be north of the DA's Office entrance where he can see from his camera when a vet arrives and he can buzz them in. He and the Maintenance supervisor have checked into the amount of handicap parking spaces that the County has and at present time there are two more than are required by law. All he is asking is one parking space for Veterans.

Motion by Lukas to put in the reserved parking space for the Veterans, second by Burl. All present voting (AYE.) Motion carried.
