DISCUSSION WITH CHIEF DEPUTY ON THE UNION CONTRACT WAGE INCREASES AND HIS CLASSIFICATION WITHIN IT, POSSIBLE ACTION ON INCREASE IN HIS WAGE BECAUSE OF THE CLASSIFICATION

Walrath explained to the committee his feelings of being included in the increase in wage of the upper level of supervisors and not the deputies. Although he is not in the union he has always increased with the union contract and the current contract was done differently which created a difference in employees never encountered before.

Motion by Chaney to stay within the budget this year and in the fall re-visit this and increase Walrath in 2021 to follow the Lieutenants and Supervisors, bringing him up .5% to be in line with them, second by Stamper. All present voting (AYE). Motion carried.

DISCUSSION AND POSSIBLE ACTION ON REPAIR THAT WAS DONE TO THE FORESTRY TRACTOR AND THE FUNDS BEING TAKEN FROM THE CAPITAL PROJECTS FUND

The Clerk explained the Forestry Department explained they did not have the funds to fix the tractor this year without depleting the vehicle maintenance fund, and they just had damage done to the UTV by an employee which is in need of fixing.
