DISCUSSION ON REPLACEMENT GENERATOR BIDS FOR THE LAW ENFORCEMENT CENTER, AND POSSIBLE APPROVAL OF BIDDER CONTRACT There were four (4) bidders, and all had the required documents, which included (1) Bid Bond, (2) Bid was signed, (3) Acknowledged Addendum's 1 & 2. The sealed bids were opened in order as follows at the bid opening at 3:30 p.m.:

- Northern Electric, Inc. Base Bid: \$252,080.00 & Alternate Bid: \$253,500.00
- Van Ert Electric Company, Inc.- Base Bid: \$262,475.00 & Alternate Bid: \$270,788.00
- Eland Electric Corporation Base Bid: \$246,803.00 & Alternate Bid: \$238,343.00
- Krueger Electric Base Bid: \$232,893.00 & Alternate Bid: \$211,752.00

The base bid consisting of a new generator for the LEC and the Alternate bid was for a smaller generator to back-up the existing generator. It was asked of Musson what his thoughts were on the new replacement or adding to the existing generator and he told the committee that his discussions with Cottrell would be a new generator and the lowest bidder specifications of the Kohler generator was acceptable.
