Town of Alvin-Ward 1 –

Total number of voters 38. No outstanding provisional ballots. Zero (0) absentee ballots. Zero (0) EDRs. Poll book is missing Chief Inspector signature. Voter on page 18 of the poll book was not assigned a voter number. Tally Sheet is missing the number of last vote. Inspectors' Statement is missing the total paper ballots and total touch screen ballots. Election night called in twenty (20) votes for Tom Tiffany, actual count nineteen (19).

Town of Argonne-Ward 1 –

Total number of voters 94. No outstanding provisional ballots. Three (3) absentee ballots. Six (6) EDRs. Inspectors' Statement is missing the total number of EDRs.

Town of Armstrong Creek-Ward 1 –

Total number of voters 77. No outstanding provisional ballots. One (1) absentee ballot. Two (2) EDRs. Tally Sheet is missing the number of last vote.

Town of Blackwell-Ward 1 –

Total number of voters 29. No outstanding provisional ballots. Five (5) absentee ballots. Zero (0) EDRs. Inspectors' Statement is missing the total number of voters.

Town of Caswell-Ward 1 –

Total number of voters 26. No outstanding provisional ballots. Three (3) absentee ballots. One (1) EDR.

Town of Crandon-Wards 1-3 –

Total number of voters 122. No outstanding provisional ballots. Three (3) absentee ballots. Four (4) EDRs. Total number of EDRs on the Inspectors' Statement should be four instead of seven as three voters registered prior to Election day. Missing the official results report from the DRE, town Clerk brought in results report.

Town of Freedom-Ward 1 –

Total number of voters 101. No outstanding provisional ballots. Seventeen (17) absentee ballots. Two (2) EDRs. Total number of absentee voters on the Inspectors' Statement needs to be the actual number of absentees counted.

Town of Hiles-Ward 1 –

Total number of voters 126. No outstanding provisional ballots. Thirty-one (31) absentee ballots. Two (2) EDRs.

Town of Laona-Wards 1-3 –

Total number of voters 190. No outstanding provisional ballots. Twenty-one (21) absentee ballots. Nine (9) EDRs.

Town of Lincoln-Wards 1-3 –

Total number of voters 180. No outstanding provisional ballots. Fifteen (15) absentee ballots. Four (4) EDRs. Total number of absentee electors on poll book says eighteen but actual is fifteen.

Town of Nashville-Ward 1 –

Total number of voters 87. No outstanding provisional ballots. Four (4) absentee ballots. One (1) EDR. Total number of ballots cast is incorrect on the Inspectors' Statement.

Town of Nashville-Ward 2 –

Total number of voters 33. No outstanding provisional ballots. Zero (0) absentee ballots. Two (2) EDRs. Total number of ballots cast is incorrect on the Inspectors' Statement.

Town of Nashville-Ward 3 –

Total number of voters 95. No outstanding provisional ballots. Fifteen (15) absentee ballots. Two (2) EDRs. Total number of ballots cast is incorrect on the Inspectors' Statement. Election night called in one hundred four (104) votes for Daniel Kelly, actual count fifty-seven (57), forty-six (46) votes for Jill J. Karofsky, actual twenty-four (24), seven (7) votes for Ed Fallone, actual four (4) changing countywide totals for Daniel Kelly to 977, Jill J. Karofsky to 343 and Ed Fallone to 104.

Town of Popple River-Ward 1 –

Total number of voters 10. No outstanding provisional ballots. Zero (0) absentee ballots.
Zero (0) EDR.

Town of Ross-Ward 1 –

Total number of voters 25. No outstanding provisional ballots. Zero (0) absentee ballots.
Two (2) EDRs. Voted on the pre lat cartridge. Tally Sheet is missing the number of last vote.
Voters on pages four and nineteen in the poll book were issued the same voter number. #10 was
not issued to any voters. Supplemental poll list is missing signatures.

Town of Wabeno-Wards 1-5 –

Total number of voters 109. No outstanding provisional ballots. Five (5) absentee ballots.
Seven (7) EDRs. Tally Sheet is missing the number of last vote. One EDR was for a voter who
moved within the voting district, registration form was incomplete, voter was recorded under
previous address.

City of Crandon-Wards 1-4 –

Total number of voters 246. No outstanding provisional ballots. Twenty (20) absentee ballots.
Twelve (12) EDRs.
