CONDUCT CANVASS OF THE APRIL 7, 2020, PRESIDENTIAL PREFERENCE, SPRING ELECTION

Town of Alvin-Ward 1 –

Total number of voters 58. No outstanding provisional ballots. Thirty (30) absentee ballots. Zero (0) EDRs. Poll book is missing the last voter number, page number of last voter and number of absentee electors. Top of tally sheets are missing the number of last vote on poll list or highest number on registration list.

Town of Argonne-Ward 1 –

Total number of voters 4. No outstanding provisional ballots. Three (3) absentee ballots. Zero (0) EDRs. The Inspectors' Statement was not separated by wards. Poll books were not numbered separately by ward. State Referenda votes were not separated by ward. Tally sheets, highest number on registration list was not separated by ward.

Town of Argonne-Ward 2 –

Total number of voters 150. No outstanding provisional ballots. Seventy seven (77) absentee ballots. Seven (7) EDRs. One EDR was a Town of Lincoln Resident. The Inspectors' Statement was not separated by wards. Poll books were not numbered separately by ward. State Referenda votes were not separated by ward.

Town of Argonne-Ward 3 –

Total number of voters 27. No outstanding provisional ballots. Fourteen (14) absentee ballots. One (1) EDR. The Inspectors' Statement was not separated by wards. Poll books were not numbered separately by ward. State Referenda votes were not separated by ward. Tally sheets, highest number on registration list was not separated by ward.

Town of Armstrong Creek-Ward 1 –

Total number of voters 146. No outstanding provisional ballots. Forty three (43) absentee ballots. Three (3) EDRs. Election night called in zero (0) votes for Republican Uninstructed Delegation, actual count one (1). Seven (7) votes for County Board District 4 Scattering, actual count twelve (12).

Town of Blackwell-Ward 1 –

Total number of voters 31. No outstanding provisional ballots. Eight (8) absentee ballots. Zero (0) EDRs.

Town of Caswell-Ward 1 –

Total number of voters 41. No outstanding provisional ballots. Thirteen (13) absentee ballots. Zero (0) EDRs. Inspectors' Statement is missing the voting unit number, memory device serial number and tamper-evident seal serial number. Late registration voted absentee, added to the post supplemental poll list.

Town of Crandon-Wards 1 –

Total number of voters 183. No outstanding provisional ballots. Ninety four (94) absentee Ballots. Two (2) EDRs. The Inspectors' Statement was not separated by wards. Tally sheet is missing the highest number on registration list. Voter on page 8 of poll book was issued two different voter numbers. Election night called in zero (0) votes for Democratic Tulsi Gabbard, actual count one (1). Zero (0) votes for Republican Uninstructed Delegation, actual count one (1). One hundred eighteen (118) votes for State Referenda Yes, actual count one hundred seventeen (117). Twenty eight (28) votes for State Referenda No, actual count fifty six (56).

Town of Crandon-Wards 2 –

Total number of voters 35. No outstanding provisional ballots. Fifteen (15) absentee ballots. Zero (0) EDRs. Tally sheet is missing the highest number on registration list. Tally sheets show more votes than voters. Board of Canvass called Town of Crandon poll workers to come in. Poll workers removed seal #0608591, opened the bag and pulled two (2) ballots. Poll workers sealed ballot bag, new seal #0608592. Had to reopen and remove two (2) more ballots because total votes were still more than total voters. New seal #0608594.

Town of Crandon-Wards 3 –

Total number of voters 18. No outstanding provisional ballots. Seven (7) absentee ballots. Zero (0) EDRs. Tally sheet is missing the highest number on registration list.

Amended at 5/19/2020 Board of Canvass Actually only six (6) absentee ballots. One voter was counted as an absentee because they didn't sign the poll book but they voted at the polls on Election day.

Town of Freedom-Ward 1 –

Total number of voters 145. No outstanding provisional ballots. Eighty eight (88) absentee ballots. Three (3) EDRs. Election night called in fifty (50) votes for Democrat Joe Biden, actual count forty (40). Zero (0) votes for Republican Uninstructed Delegation, actual count one (1).

Town of Hiles-Ward 1 –

Total number of voters 175. No outstanding provisional ballots. One hundred twelve (112) absentee ballots. Two (2) EDRs.

Election night called in one (1) vote for Democrat Michael Bloomberg, actual count zero (0). One (1) vote for Republican Uninstructed Delegation, actual count zero (0).

Town of Laona-Wards 1 –

Total number of voters 118. No outstanding provisional ballots. Sixty seven (67) absentee ballots. Zero (0) EDRs. State Referenda votes were not separated by ward.

Town of Laona-Wards 2 –

Total number of voters 91. No outstanding provisional ballots. Thirty five (35) absentee ballots. Four (4) EDRs.

State Referenda votes were not separated by ward.

Town of Laona-Wards 3 –

Total number of voters 108. No outstanding provisional ballots. Fifty one (51) absentee ballots. Two (2) EDRs. State Referenda votes were not separated by ward. Election night called in zero (0) votes for County Board District 6 Scattering, actual count one (1).

Town of Lincoln-Wards 1 –

Total number of voters 222. No outstanding provisional ballots. One hundred forty nine (149) absentee ballots. Six (6) EDRs. The Inspectors' Statement was not separated by wards. Poll books were not numbered separately by ward. State Referenda votes were not separated by ward. Absentee voter #65 was not marked on page 5 of the poll book. Absentee voter #122 was not marked on page 24 of the poll book.

Town of Lincoln-Wards 2 –

Total number of voters 32. No outstanding provisional ballots. Nineteen (19) absentee ballots. One (1) EDRs. The Inspectors' Statement was not separated by wards. Poll books were not numbered separately by ward. State Referenda votes were not separated by ward.

Town of Lincoln-Wards 3 –

Total number of voters 93. No outstanding provisional ballots. Fifty five (55) absentee ballots. Four (4) EDRs. The Inspectors' Statement was not separated by wards. Poll books were not numbered separately by ward. State Referenda votes were not separated by ward.

Town of Nashville-Ward 1 –

Total number of voters 142. No outstanding provisional ballots. Seventy nine (79) absentee ballots. Three (3) EDRs. Last voter number on the poll book and Inspectors' Statement were incorrect because voter numbers 52, 53, 54 and 96 were all issued twice. Correct last voter number is 142.

Town of Nashville-Ward 2 –

Total number of voters 89. No outstanding provisional ballots. Twelve (12) absentee ballots. Thirteen (13) EDRs. Election night called in one (1) vote for Republican Uninstructed Delegation, actual count zero (0). Board of Canvass was not given poll book with voter signatures.

Town of Nashville-Ward 3 –

Total number of voters 110. No outstanding provisional ballots. Fifty two (52) absentee ballots. Five (5) EDRs. Board of Canvass was not given poll book with voter signatures. Election night called in three (3) votes for Democrat Bernie Sanders, actual count five (5). Two (2) votes for County Board Supervisor District 12 Laabs, actual count three (3). Zero (0) votes for County Board Supervisor District 12 Scattering, actual count three (3).

Town of Popple River-Ward 1 –

Total number of voters 19. No outstanding provisional ballots. Five (5) absentee ballots. Zero (0) EDRs. Inspectors' Statement is missing the Chief Inspector's initials on the pre-election and post-election tamper evident seal numbers. Election night called in six (6) votes for Circuit Court Judge Robert A. Kennedy, actual count four (4).

Town of Ross-Ward 1 –

Total number of voters 30. No outstanding provisional ballots. Seven (7) absentee ballots. Zero (0) EDRs. Total number of absentee voters on the Inspectors' Statement is incorrect. Tally sheets are missing the highest number on registration list. Absentee voters were not marked in red on the poll book. Election night called in six (6) votes for Democratic Tulsi Gabbard, actual count zero (0). Sixteen (16) votes for State Referenda Yes, actual count twenty (20).

Town of Wabeno-Wards 1 –

Total number of voters 84. No outstanding provisional ballots. Thirty five (35) absentee ballots. Four (4) EDRs. The Inspectors' Statement was not separated by wards. Poll books were not numbered separately by ward. State Referenda votes were not separated by ward.

Town of Wabeno-Wards 2 –

Total number of voters 16. No outstanding provisional ballots. Seven (7) absentee ballots. Zero (0) EDRs. The Inspectors' Statement was not separated by wards. Poll books were not numbered separately by ward. State Referenda votes were not separated by ward.

Town of Wabeno-Wards 3 –

Total number of voters 27. No outstanding provisional ballots. Eleven (11) absentee ballots. Four (4) EDRs. The Inspectors' Statement was not separated by wards. Poll books were not numbered separately by ward. State Referenda votes were not separated by ward.

Town of Wabeno-Wards 4 –

Total number of voters 83. No outstanding provisional ballots. Twenty seven (27) absentee ballots. Five (5) EDRs. The Inspectors' Statement was not separated by wards. Poll books were not numbered separately by ward. State Referenda votes were not separated by ward.

Town of Wabeno-Wards 5 –

Total number of voters 16. No outstanding provisional ballots. Five (5) absentee ballots. One (1) EDR. The Inspectors' Statement was not separated by wards. Poll books were not numbered separately by ward. State Referenda votes were not separated by ward.

City of Crandon-Wards 1 –

Total number of voters 94. No outstanding provisional ballots. Thirty nine (39) absentee ballots. Five (5) EDRs. Poll books were not numbered separately by ward. Election night called in zero (0) votes for Democrat Tulsi Gabbard, actual count two (2). Zero votes for Democrat Amy

Klobuchar, actual count two (2). Twenty seven votes for Democrat Joe Biden, actual count seventeen (17). One (1) vote for Republican Uninstructed Delegation, actual account two (2). Twenty six (26) votes for State Referenda No, actual count sixteen (16). One vote for County Board Supervisor District 18 Scattering, actual count zero (0).City of Crandon-Wards 2 –

Total number of voters 125. No outstanding provisional ballots. Sixty six (66) absentee ballots. Five (5) EDRs. Poll books were not numbered separately by ward. Election night called in zero (0) votes for County Board Supervisor District 19 Scattering, actual count one (1).

City of Crandon-Wards 3 –

Total number of voters 116. No outstanding provisional ballots. Fifty four (54) absentee ballots. Five (5) EDRs. Poll books were not numbered separately by ward. Tally sheets show more votes Than voters. Board of Canvass called City of Crandon poll workers to come in. Poll workers Removed seal #1192621, opened the bag and pulled four (4) ballots. Poll workers sealed ballot bag, new seal #0608593. Changes in tally:
