APPROVE MINUTES OF THE APRIL 7, 2020, BOARD OF CANVASS

Motion by Mayer to amend the April 7, 2020 Board of Canvass as the Town of Crandon Ward 3 actually had six (6) absentee voters, not seven (7). One in person voter did not sign poll book and was originally counted as an absentee. Seconded by Matuszewski. All present voting AYE.

CONDUCT CANVASS OF THE MAY 12, 2020 SPECIAL ELECTION FOR CONGRESSIONAL DISTRICT 7

Town of Alvin-Ward 1 –

Total number of voters 51. No outstanding provisional ballots. Twenty one (21) absentee ballots. Zero (0) EDRs. Tally sheet is missing the highest number on registration list. Voter on page #10 and page #13 had voter signature but no voter number.

Town of Argonne-Ward 1 –

Total number of voters 140. No outstanding provisional ballots. Sixty two (62) absentee ballots. Zero (0) EDRs. Poll book is missing the last voter number. Total hand-count paper ballots on the Inspectors' Statement was incorrect. Said five (5), actual total sixty seven (67).

Town of Armstrong Creek-Ward 1 –

Total number of voters 133. No outstanding provisional ballots. Forty three (43) absentee ballots. Two (2) EDRs. There was an absentee ballot that was marked as returned on the absentee log but was not actually returned.

Town of Blackwell-Ward 1 –

Total number of voters 29. No outstanding provisional ballots. Eight (8) absentee ballots. Zero (0) EDRs.

Town of Caswell-Ward 1 -

Total number of voters 32. No outstanding provisional ballots. Eight (8) absentee ballots. Zero (0) EDRs. Memory device serial number missing from Inspectors' Statement.

Town of Crandon-Wards 1-3 –

Total number of voters 160. No outstanding provisional ballots. Fifty nine (59) absentee ballots. One (1) EDR. Inspectors' statement says three (3) EDRs, actual count is one (1). Two of the applications were late registrations, they signed the supplemental poll book on election day.

Town of Freedom-Ward 1 –

Total number of voters 150. No outstanding provisional ballots. Seventy (70) absentee ballots. Two (2) EDRs.

Town of Hiles-Ward 1 –

Total number of voters 168. No outstanding provisional ballots. One hundred eleven (111) absentee ballots. Zero (0) EDRs. Incident recorded on incident log states voter #99 and voter #29 signed each others poll book signature line error.

Town of Laona-Wards 1-3 –

Total number of voters 306. No outstanding provisional ballots. One hundred seventy one (171) absentee ballots. Zero (0) EDRs. Voter #30 signed on wrong line in poll book.

Town of Lincoln-Wards 1-3 –

Total number of voters 323. No outstanding provisional ballots. One hundred seventy nine (179) absentee ballots. Three (3) EDRs. Page 34, 60 and 64 of the poll book all had "AB" written by names but no voter numbers issued.

Town of Nashville-Ward 1 –

Total number of voters 130. No outstanding provisional ballots. Sixty five (65) absentee ballots. Zero (0) EDRs.

Town of Nashville-Ward 2 –

Total number of voters 73. No outstanding provisional ballots. Sixteen (16) absentee ballots. Three (3) EDRs. Voter #63 was used a second time on page 23. Voter #62 was not issued.

Town of Nashville-Ward 3 –

Total number of voters 137. No outstanding provisional ballots. Fifty seven (57) absentee ballots. One (1) EDR. Absentee voters on page 29 of the poll book were not marked with a red "AB".

Town of Popple River-Ward 1 –

Total number of voters 19. No outstanding provisional ballots. Four (4) absentee ballots. Zero (0) EDRs. Voter on page 7 of the poll book did not sign. Absentee voters were not marked in red ink.

Town of Ross-Ward 1 -

Total number of voters 47. No outstanding provisional ballots. Six (6) absentee ballots. One (1) EDR. Number of DRE (touch screen) is missing from the Inspectors' Statement. Highest voter number missing from the tally sheet. Absentee voters were not marked in red ink.

Town of Wabeno-Wards 1-5 –

Total number of voters 208. No outstanding provisional ballots. Seventy four (74) absentee ballots. Two (2) EDRs.

City of Crandon-Wards 1-4 –

Total number of voters 394. No outstanding provisional ballots. One hundred ninety five (195) absentee ballots. Two (2) EDRs. Poll book missing last voter number, page number of last voter and number of absentee electors. Inspectors' statement is missing number hand-count paper ballots. Voter #316 was used for a second time on page 104 of poll book. Voter # 324 & 325 were not issued. City of Crandon recorded 395 votes in WisVote. Called Clerk to compare poll books. One voter was recorded that shouldn't have been. The City corrected on their end.
