DISCUSSION AND REVIEW OF THE CAPITAL PROJECTS FUND; POSSIBLE ACTION ON A RESOLUTION FOR FULL COUNTY BOARD No Action

DISCUSSION AND POSSIBLE ACTION ON THE 2021 BUDGET

The Health Insurance renewal came in at 4% increase, the agent is going to try to get it down to zero.

The budget has over a \$400,000 shortfall. The board members went line by line and reduced or increased items as follows:

- Increased Sales Tax Revenue to \$600,000
- Increased Penalty on Taxes to \$25,000
- Removed \$10,000 from I.T. Outlay
- Jail decreased minor repairs to \$7,000, Boiler repairs to \$1,000, Office Supplies to \$2,500, Travel to \$2,500, Supplies to \$1,000, Miscellaneous to \$1,500, & Equipment to \$2,800
- Judge- Re-panel Office \$2,590 to come out of \$5 million borrowing, lowering Outlay to \$600, Office supplies decreased to \$2,600, Travel to \$2,300
- Sheriff Decreased Repairs/Squad Radio/Siren to \$1,000, Travel-Sheriff/Chief Deputy to \$250, Travel, Miscellaneous Deputies to \$500, and Equipment to \$4,000

- UW Extension -Reduced Outlay to \$0
- Veterans Veteran's Transportation decreased to \$300 & Training decreased to \$1,000
- Zoning Permits increased to \$58,000
- Recreation Officer Miscellaneous decreased to \$200
- Health Department Increased Public Health Misc. Revenues to \$5,000
- Health Department (PH) Decreased telephone to \$400, Office supplies to \$800, Travel/Training to \$1,300, Miscellaneous to \$1,800 & Vehicle to \$250
- Health Department Lifeline decreased photocopies to \$0, Equipment Maintenance to \$100
- Health Department Lead Decreased Miscellaneous to \$300
- Social Services Administration- Decreased Supplies to \$400 & Travel Training to \$800
- Social Services Services Decreased Supplies to \$100, Travel & Training to \$550 & Miscellaneous to \$150
- Social Services Elder Abuse Decreased Client needs to \$5,000
- Social Services Client Service Payments Decreased to \$200,000
- Social Services DCF Decreased Travel/Training to \$6,000

The decreases brought down the deficit below \$400,000, there are a few more departments that need to be looked at for the next meeting.

Motion by Collins to approve the Health Renewal at the 4% contingent on the agent getting it reduced lower, second by Chaney. All present voting (AYE). Motion carried
