**CONDUCT CANVASS OF THE NOVEMBER 3, 2020, GENERAL ELECTION**

**Town of Alvin-Ward 1 –**

Total number of voters 103. No outstanding provisional ballots. Twenty six (26) absentee ballots. Six (6) EDRs. Inspectors' Statement has one hundred two (102), actual is one hundred three (103). Voter #1 was used twice in the poll book. Missing total number of EDRs, actual six (6). Number of absentee voters thirty three (33), actual twenty six (26). Tally sheet is missing the highest number on registration list. Absentees are not numbered with red ink in the poll book. Page 12 of the poll book has a voter with no voter number. Page 16 of the poll book has an "A" on an absentee voter, but no voter number.

Poll book certification is missing last voter number, page number of last voter and number of absentee electors. No voter signatures on the supplemental poll list. Pages 2, 13, and 36 of the poll book has a voter signature with no voter number. Page 51 of the poll book has a voter number but no voter signature. Four voters who filled out voter registration applications to change their name or address should have signed the supplemental poll list instead of the poll book. One EDR did not sign their voter registration application.

Total number of voters 274. No outstanding provisional ballots. One hundred forty seven (147) absentee ballots. Ten (10) EDRs. Highest number on registration list missing from the Legislative and State tally sheet.

**Town of Laona-Wards 1-3 –**

Total number of voters 675. No outstanding provisional ballots. Two hundred sixty (260) absentee ballots. Forty nine (49) EDRs.

**Town of Lincoln-Wards 1-3 –**

Total number of voters 592. No outstanding provisional ballots. Two hundred forty one (241) absentee ballots. Forty one (41) EDRs. One voter registered at the polls, but lives outside jurisdiction, vote was recorded in Town of Lincoln. Tally sheets are missing highest number on registration list.

**Town of Nashville-Ward 1 –**

Total number of voters 232. No outstanding provisional ballots. Sixty three (63) absentee ballots. Fourteen (14) EDRs. Inspectors' Statement says 15 EDRs, actual 14. Tally sheet is missing highest number on registration list.

**Town of Nashville-Ward 2 –**

Total number of voters 186. No outstanding provisional ballots. Thirty eight (38) absentee ballots. Twenty six (26) EDRs. Inspectors' Statement says 27 EDRs, actual 26.

**Town of Nashville-Ward 3 –**

Total number of voters 249. No outstanding provisional ballots. Ninety (90) absentee ballots. Seventeen (17) EDRs. Inspectors’ Statement says 20 EDRs, actual 17. Tally sheets are missing highest number on registration list. President/Vice President totals and Representative in Congress District 7 totals on tally sheet equal more than total number of voters on poll list. Town of Nashville poll workers were called in to recount votes. Poll workers removed Seal#0608563 from Bag #1 of 1. During the recount, poll workers discovered one ballot too many. One random ballot was pulled and ballots were re-counted.

Total number of voters 25. No outstanding provisional ballots. Thirteen (13) absentee ballots. Zero (0) EDRs.

**Town of Ross-Ward 1 –**

Total number of voters 84. No outstanding provisional ballots. Fifteen (15) absentee ballots. Seven (7) EDRs. Tally sheets are missing highest number on registration list. Poll book certification says last voter number 82, actual 84. One voter completed voter registration application because of a name change, this voter signed the poll book but should have signed the supplemental poll list. Absentees are not numbered with red ink in the poll book.

**Town of Wabeno-Wards 1-5 –**

Total number of voters 522. No outstanding provisional ballots. One hundred nineteen (119) absentee ballots. Sixty three (63) EDRs. Eleven of the EDR applications were incomplete, votes were still counted. Page 66 of poll book had a voter with a signature but no voter number. Voter #313 in the poll book did not have a signature.

**City of Crandon-Wards 1-4 –**

Total number of voters 842. No outstanding provisional ballots. Two hundred eighty three (283) absentee ballots. Seventy five (75) EDRs.

One voter registered at the polls, but lives outside jurisdiction, vote was recorded in City of Crandon. Inspectors’ Statement says 282 absentee ballots, actual 283. Inspectors’ Statement says 840 total voters, canvassers identified 842 voters in the poll book. City of Crandon Clerk was called in to reconcile the Municipality and County’s Poll Book. Both poll books confirm 842 voters. Representative in Congress District 7 totals on tally sheet equal more than total number of voters on poll list.
