TOUR OF OLD JAIL RESIDENCE

PERSONAL APPEARANCE FROM BRIAN SCHULTZ; HISTORICAL SOCIETY

Brian was in to discuss with the committee ideas that the Society had with the Jail residence and the progress made to date.

PERSONAL APPEARANCE FROM JEFF MUSSON; COURTHOUSE FLOOR COVERINGS The committee asked Jeff to work on bidding out all floors in offices in commercial vinyl, all the same color. The hallways need to be done all in the same material and color as well, with the abatement being done through the grinding process.

Musson updated the committee on other projects bid out as well. He planned on bidding the roofs, but no contractors showed up for the showing. He will work on bidding again in January or February 2021, at that time he will only need to change the dates on his paperwork. The committee was concerned with the timing considering there could be snow. The door and windows were awarded to Argonne Lumber. He also told the committee that the Call Center is
