UPDATE ON ONGOING PROJECTS.

Forestry Administrative Assistant informed the committee about the HWY 8 Trail to Oneida County not needing a H&H Study pursuant to Jared Seidl-DNR Water Specialist due to minimal change in the grade and not affecting the flow of the creek. Katie will be contacting Oneida County Forestry Department to see about the progress on their end.

Section 9 Block Acquisition-need title commitment.

Staff working on finishing up on 15 Year Comprehensive Plan.

PUBLIC COMMENTS ON AGENDA ITEMS.

Lukas mentioned that a snowmobile club was concerned about entries in SNARS and that the county was not submitting reimbursements to the clubs on a timely manner. The also mentioned about GPS not matching the trails. The SNARS approvals and payment reimbursement are submitted weekly providing the club has funding available. Nathan Matter expert in SNARS will be attending the next snowmobile meeting on March 3, 2021.

A concern with the bridges on Nicolet State Trail. Bridge quotes have been requested and the county will work on most needed bridge repair. The county will work on submitting at least 2 bridge projects per year.
