DISCUSSION AND POSSIBLE ACTION – COVID-19 UPDATES:

Shepard shared current Forest County COVID Disease Activity level being Medium and current Burden of 32.7 being Moderately High. Total cases in Forest County as of 4/2/21 is 939.

Shepard shared 32.6% (or 2,938) of Forest County residents have received at least one dose and 25.1% (or 2,257) have received both doses. 72.3% of residents 65 and older have received one dose and 64.4% have received both doses.

Shepard shared they have received their first allocation of Johnson & Johnson vaccine and are making plans to make that available to the community.

FCHD still has not received the contract for the \$297,100 ELC grant but has heard from the state that it should be coming soon.

DISCUSSION AND POSSIBLE ACTION – HEALTH OFFICER/DIRECTOR JOB POSTING UPDATE:

Committee discussed that the job posting was going to finance for potential approval of updated wage. Position will then be posted until April 30th.

DISCUSSION AND POSSIBLE ACTION – WIC PROGRAM AND POTENTIAL MERGER:

Shepard discussed options for a potential merger with Oneida County WIC as FCHD did not receive any applicants for WIC Director/Project Nutritionist position. Shepard will continue to work with WIC Regional Contact for guidance during this process.

Motion by Collins for FCHD to pursue WIC program merger with Oneida County Health Department, second my Moore. All present voting (AYE). Motion carried.
