- Johnson Controls will be working on the Jail issue with the HVAC in the middle of May. Rinehart explained the problem with this unit will never be a correct replacement, but, they will get some controls that will make is manageable.
- Rinehart ordered 6-lights for the Child Support office to try out. He would like to try the new type of lights instead of having two (2) in the office.
- There have been issues with the toilets and being plugged. Rinehart is not sure how to resolve the issue.
- Rinehart has been trying to get a cable for the GPS weather monitor from the Jail basement through a pipe that goes to the outside of the building. The Jail cannot go live without this being done and it is proving to be a very difficult task.
