- The break-room and vaults are not in the floor projects. Maintenance can paint them.
- Armstrong Heating and Cooling will begin work, but would like to come in on a Saturday
  and Sunday to do some of the work, so as not to cause disruption with the daily
  operations and court.
- There will be discussion at County Board level on the mural in the boardroom and what to do with it.
