DISCUSSION AND POSSIBLE ACTION ON THE AMERICAN RESCUE PLAN ACT

Matt Osterman discussed with the committee the potential to secure 3:1 match with the current ARPA funding the county has. The extra funding added to it would ensure more fiber in the ground and coverage to residents that do not have coverage. Areas discussed were Peshtigo River Road in Laona, Camp 6 in the Bear Lake area and the Ross area. He asked the committee to look into getting letters of support from other businesses in town and the towns, as this would help in securing a grant. The grant has to be written by July 27th, so the committee has work to do to get letters. Matt told the committee he has a form letter, but the personal one's look better. The committee wants to make sure they know what is going on and want progress reports as much as possible from Osterman. Osterman told the committee Oneida County will be trying to secure this additional grant as well, so that may help as well.

Motion by Collins to have Northwoods Connect (Osterman) pursue an additional grant for Broadband through the PSC, second by Chaney. All present voting (AYE). Motion carried.
