Brenda Flannery told the committee that until they have a parcel purchased she would not be able to look into a grant for the infrastructure. She told the committee grants are not for the purchase of the property, so they need that first.

The Fair is September 10-12, and Fair books will be available in the next few weeks. They will have old fair books available for the entries.
