MONTHLY SALES TAX

The monthly sales tax increased from July 2020 to July 2021 by \$3,388.81, yearly sales tax amounts up for the year by \$53,216.45, so the county is on track to meet or exceed budgeted amounts.

• GENERAL OBLIGATION DEBT SPENDING

The Clerk had a spread sheet for everyone to look over showing the balances in all capital outlay accounts.
