- Motion by Collins to start Schmidt at the full wage of \$18.47, second by Berg. All present voting (AYE). Motion carried.
- Motion by Collins to eliminate the education pay for the Jail employees starting with the budget year 2022, second by Chaney. All present voting (AYE). Motion carried.
- Motion by Campbell to not allow a Uniform cleaning allowance for the dispatch employees, send to full county board in resolution form, second by Chaney. All present voting (AYE). Motion carried.
- Motion by Collins to separate the DSS/COA departments and employees, have the department heads bring in updated job descriptions for both, second by Goode. All present voting (AYE). Motion carried.

### DISCUSSION AND POSSIBLE ACTION ON POSTING THE FORESTRY ADMINISTRATIVE ASSISTANT

Motion by Campbell to post the position, second by Collins. All present voting (AYE). Motion carried.

# DISCUSSION AND POSSIBLE ACTION ON THE MAINTENANCE SUPERVISOR JOB DESCRIPTION

Motion by Collins to forward position job description on to the Building committee for updates, second by Berg. All present voting (AYE). Motion carried.

### DISCUSSION AND POSSIBLE ACTION ON POSTING BUS DRIVER POSITION FOR AGING DEPARTMENT

Queen asked to revise the job description to add stand-by pay for the drivers. The committee suggested ½ pay for 8 hours at \$7.50 per hour but, could not make a decision until the job description is brought back her committee and updated, then it can be brought back for discussion and approval.

Motion by Goode to post the position as is for now, second by Berg. All present voting (AYE). Motion carried.

# DISCUSSION AND POSSIBLE ACTION ON A FAMILY SUPPORT SPECIALIST POSITION WITHIN THE SOCIAL SERVICES

Jensen brought forth a new position that is being mandated either as a new employee or a contract worker. The position is mandated but not funded. Motion by Campbell to approve the position and move forward to full county board in resolution form, second by Collins. All present voting (AYE). Motion carried.

### DISCUSSION AND POSSIBLE ACTION ON A LEAD SOCIAL WORKER POSITION WITHIN SOCIAL SERVICES

Motion by Gretzinger to approve the position, and bring back an updated job description from the Social Services committee for possible forwarding to full county board, second by Chaney. All present voting (AYE). Motion carried.
