DISCUSSION AND POSSIBLE ACTION ON REPAIR TO THE BEDS IN THE JAIL Motion by Collins to have Maintenance follow through with repairs to the Jail beds, second by Dehart. All present voting (AYE). Motion carried.

UPDATES ON NEW AND EXISTING BUILDING PROJECTS WITH MUSSON AND HOFFMAN; POSSIBLE ACTION

• A change order was presented for the new registers, when the old units were removed they covered more floor space than the new ones. There is a need to drill new holes for the electric at a cost of \$1,525.

Motion by Laabs to approve the change order, second by Collins. All present voting (AYE). Motion carried.

• Replacing the light fixtures (2X4 florescent) will cost the county an additional \$28,931, which is going to make the time to finish the project pushed out if not dealt with immediately.

Motion by Dehart to install the light fixtures for the additional \$28,931 under an emergency need because of scheduling and court system needs, second by Collins. All present voting (AYE). Motion carried.

- The demo of the acoustical ceilings came in at a cost of around \$115,476. Motion by Laabs to have the work performed under the emergency need because of scheduling and court system needs, second by Collins. All present voting (AYE). Motion carried.
 - The 2x2 drop in lights and 10-penant lights can be purchased in house for around \$14,155.

• There was discussion on the restoration of the dome pictures that are starting to peel and fall down.

Motion by Collins to get a quote for the restoration of the dome, second by Laabs. All present voting (AYE). Motion carried.

UPDATES WITH MAINTENANCE; POSSIBLE ACTIONS

- The pumps for the North Annex will be in within the next few weeks.
- Rinehart wanted to put in a reminder of the three floors that need to be done in the Sheriff Department.
- Rinehart asked that the Fair staff get ahold of the Maintenance two weeks before the Fair to start opening things up and checking for repairs. They have been down to the grounds several times this week right before the Fair.
- Rinehart is working with Johnson Controls on the zone values with the air conditioning. It is not working correctly.
- The Judge called and told Maintenance they have a jury trial on November 8th and he needs his courtroom up and running before that date.
- WPSC will be here on September 20th to remove the extra meter on the Forestry garage.
- There will be no electricians in the building next week.
- Rinehart submitted his resignation for October 1st and would like to be paid out his 240 hours of sick time. This is a Personnel matter.
