The total budget for transportation is \$107,867.00. There were no public comments.

Nutrition program funds were underspent during the last year and those funds have been returned to the state's general fund to be used for other programs and services.

Queen reports that the Senior Resource Directory requires updates. Members of the Commission on Aging Committee will be assisting with updating this directory. Winnie and Ron Krueger have

decided to retire from delivering meals for Crandon. We wish them well and thank them for their years of service. Queen is in the process of recruiting drivers. Queen reported that there had been no applications for the bus driver positions. The stipend proposal will be on the agenda for Thursday's Personnel Committee meeting. Queen reports that the date to return to the courthouse has been moved between the dates of November 15-22.
