CLOSED SESSION

DISCUSSION WITH LAURA LANEY – AMERICAN TOWER; POSSIBLE ACTION Laura was unable to attend.

Motion by Chaney to table the discussion with Laura until the next scheduled Finance meeting, second by Anderson. All present voting (AYE). Motion carried.

DISCUSSION/ACTION ON ECONOMIC DEVELOPMENT COORDINATOR MOU WITH THE CHAMBER/COUNTY/FCEDP

Motion by Gretzinger to recommend approving the MOU presented by Ferris for the position; finalized by Paul Payant and then forwarded on to full county board in resolution form, second by Chaney. All present voting (AYE). Motion carried.

DISCUSSION WITH SHERIFF ABOUT TECHNOLOGY UPDATES WITH OPIOID SETTLEMENT MONEY; POSSIBLE ACTION

The settlement money has strict uses and the Sheriff has ideas for uses. One being the MAT program for opioid and alcohol addiction and another the SUDS program. He will get more information for the programs and bring them back to finance for usage approval when the funds become available.

DISCUSSION WITH SHERIFF ON SGT'S QUOTE; POSSIBLE ACTION

The Sheriff explained they need a Public Safety Building Security Systems Upgrade. The cost will be \$549,079.32.

Motion by Chaney to allow the upgrade and use general obligation debt funds to pay for it; forward a resolution to full county board to that effect, second by Anderson. All present voting (AYE) (4); Opposed (1), Lukas. Motion carried.

DISCUSSION AND POSSIBLE ACTION ON THE COUNTY PURCHASE OF A HYDRAULIC LIFT No Action

DISCUSSION AND POSSIBLE ACTION ON THE LABOR FOR THE BUILDING AT THE VETERAN'S PARK TO HOUSE THE RECUMBENT BICYCLES

There was discussion on this project and the need for it to move forward. The grant from the Aging department will cover the bicycles and the building, but, not the labor to build it, and this project needs to move forward because the money should have been spent already.

DISCUSSION AND POSSIBLE ACTION ON THE PURCHASE OF A THERMAL PRINTER FOR EMPLOYE BADGES

Motion by Gretzinger to purchase the thermal printer for the employee badges out of Contingency funds, second by Chaney. All present voting (AYE). Motion carried.

• Monthly Sales Tax

Monthly Sales tax is down this year for the last two months.

• Human Service Center

The Clerk had a meeting with the other counties involved with the Human Service Center and was informed there is a surplus in their fund again this year.

• General Obligation Debt Balances

The Clerk showed the committee the balances remaining in all of the Capital Outlay funds: General Obligation Debt - \$1,019,722.69

Capital Projects - \$19,596.32

Road Construction - \$16,621.27

Capital Projects Balance before 2018 - \$24,912.92

Debt Issuance – General Obligation Debt - \$32,692.92

CELLPHONE PROJECT - UPGRADE

Motion by Chaney to amend the agenda to add cellphone project because of an emergency situation, second by Campbell. All present voting (AYE). Motion carried.

There was an issue with the radios and the need for better radio coverage for deputies, and the need to update to Firstnet. The cost is around \$59,540.22, with some credits to come from the existing program.

Motion by Chaney to purchase the cellphones and pay for the proceeds out of the Sheriff Department budget, if there is a shortfall at the end of the year, a budget amendment will be done, second by Campbell. All present voting (AYE). Motion carried.
