PUBLIC COMMENT

Greg Brokmeier spoke to the committee for the Highway employees. He told the committee the Highway employees are asking for a raise because the cost of living has gone through the roof and the gas prices have increased by 49%. He also said they have to obtain a CDL and they are on-call 24/7, 365 days per year. He told the committee the stress level is high in the department, during COVID they were deemed essential workers and they had no option but to come to work. They are looking for a 15% to 20% increase in wage.

- Mental Health Screener will be tabled until the Sheriff comes back with a possible plan he is working on.
- Motion by Lukas to approve the Dispatch Administrator job change, bring back updated job descriptions to Personnel for approval and then forward to Finance for the 2023 budget year, second by Landru. All present voting (AYE). Motion carried.
