Littleton did a huge majority of it and worked with the state to fix issues. The department and the committee is looking to increase the LIO salary from \$4,000 to \$6,000 and to add an additional duty to the Land Information/GIS Tech to be a deputy and get an additional salary/stipend of \$4,000 added to the position. When the department/committee hired a surveyor there is a lot more work that needs to be done and setting the corners has to get done. Motion by Chaney to update the Land Information/GIS/Land Conservation Technician to include (Deputy) add the \$4,000 stipend to it and forward on to Finance for possible approval, second by Berg. All present (AYE). Motion carried.
