### DISCUSSION AND POSSIBLE APPROVAL FOR BODY CAM FUNDING

FROM GOVENOR'S GRANT. Sheriff Skallerud advised the committee that the Sheriff's Office received a grant from the Governor's Office in the amount of \$19,939.91. Skallerud explained there are only certain eligible items the grant money can be spent on. One of the items being body cameras and associated equipment. Skallerud advised he has a contract from Visual Labs that would use the 1<sup>st</sup> Net cell phones used by the Sheriff's Office as a body camera. Motion by Piasini to sign the 1 year contract with Visual Labs, second by Tallier. All present voting (AYE). Motion carried.

### DISCUSSION, UPDATE AND POSSIBLE ACTION ON MENTAL HEALTH ISSUES

Sheriff Skallerud advised the committee of problems that have been encountered with The Human Service Center reference mental health issues in Forest County. Tallier made a motion to forward the issue to the Rules and Regulations committee to adopt a committee or commission for the following: Review the current policies and procedures of The Human Service Center located in Rhinelander WI. Report back to the full Forest County Board by July 1<sup>st</sup> 2023 as to its findings and possible future recommendations if any. Our goal is to ensure the residents of Forest County get the most appropriate behavioral health treatment available, second by Piasini. All present voting (AYE). Motion carried.

# DISCUSSION AND POSSIBLE ACTION ON A RESOLUTION FOR STATE ESINET GRANT TO BE FORWARDED TO THE FULL COUNTY BOARD.

Sheriff Skallerud explained the need for a resolution from the full County Board naming the Forest County Dispatch Center (PSAP) as the ESINET. This would allow the Sheriff's Office to apply for grants. Motion by Campbell to forward a resolution to the full County Board naming the Forest County Dispatch Center as an ESINET and pursue the grant, second by Peterson. All present voting (AYE). Motion carried.
