DISCUSSION AND POSSIBLE ACTION ON THE WORKFORCE DEVELOPMENT GRANT

There was a long discussion on what the grant could be used for other than bonuses which were discussed such as additional staff, contact tracers, training and core competencies. Wozniak explained the plan was set up to retain the staff and written in a way to make sure employees did not take the money and then go somewhere else; which has happened in other counties. Chaney did not want any money going back to the state for any reason. Black had a quarterly breakdown sheet for all to examine and it had the stipends(bonuses) from the original plan. Goode explained in light of discussions his opinion has changed and thought the stipends(bonuses) should be paid according to the plan. Dailey suggested doubling the payments because there is money available for that, but not paying people that left, just double payment going forward. Motion by Dailey to pay-out stipends to staff still in department according to Black's sheet, but double the payments, second by Berg. All present voting (AYE)(4); (NAY) (1) Lukas; (ABSTAIN)(1) Anderson. Motion carried.

DISCUSSION ON HEALTH DEPARTMENT STAFF WAGES AND POSSIBLE ACTION ON FORWARDING TO FINANCE

Motion by Chaney to forward to Finance, second by Goode. All present voting (AYE). Motion carried.

DISCUSSION AND POSSIBLE ACTION ON AGING DIRECTOR INTERIM PAY

Motion by Goode to approve backpay for K. Fohrman of \$1.27 per hour retroactive to when the previous director (Queen) left, second by Chaney. All present voting (AYE). Motion carried.

Motion by Chaney to approve the 10-hour work schedule from 7:00am-5:30pm, as long as there is coverage in the office, revisit in 6-months; with one caveat to work 5-day schedule if there is less than two (2) staff in the office in a week, second by Goode. All present voting (AYE). Motion carried.

Motion by Campbell to approve the updated job description and employee wage structure; approve the starting wage for K Pierce as a licensed social worker \$25.00 per hour, per the Social Services committee recommendation on hire, second by Goode. All present voting (AYE). Motion carried.
