### UPDATE ON THE 2022 FAIR

Brenda Flannery told the committee the Fair books will come out on Monday and that the Fair will be run the same as usual just without a carnival. (August 19-21) The carnival will not be part of the fair this year because they are requesting \$30,000 from the county to come and the county cannot afford that. Brenda Flannery thinks the carnival leaving is an opportunity. Gobert agreed and told the committee the Fair is a celebration of the county. She felt there is a need to have more volunteers to help plan it and start earlier with the planning.

### DISCUSSION AND POSSIBLE ACTION ON THE 4-H BARN AND SAFETY PROJECT AND POSSIBLE BARN UPGRADE

Amy Kuebler asked to have the barn stalls fixed, without them fixed their animals will not be able to stay in the stalls overnight. Hometown Trolley volunteered to donate the boards and the screws to fix the stalls. Weber will volunteer his time to oversee the project. The 4-H has money to fix the stalls, but they were told to hold off because of the discussions to move the Fair.

There was discussion as to who is responsible for maintaining the grounds and the Building/Property chair, Lukas said the maintenance workers are responsible.

## DISCUSSION AND POSSIBLE ACTION ON FUTURE FAIR PROPERTIES; PRICES AND VALUES

Brian Schultz asked about moving the Fair to Wabeno; to at least consider it.

Black asked for a list of the Citizen Fair members and meeting minutes for the committee to review.

Dehart has reached to Phyllis Wagoner again on the property not far from town; this is still an option. Paul Newton has a property in town that is 5.3 acres, but it is assessed at \$92,000 and there is a big hole in the middle of it. Bucky Daily had a property, but that may not be an option now.

# DISCUSSION WITH HOMETOWN TROLLEY, THE CITY AND PAUL PAYANT ABOUT THE FUTURE OF THE FAIRGROUNDS

Kristine Dunow discussed with the committee "two issues," she could see. Hometown Trolley will need more land, not immediately, but maybe in the next year or so. If they are unable to expand someone else will. The other would be what and where the Fair could be moved or held in the meantime. The Fair land could be purchased and the grounds still used until the expansion was needed, or the Fair could be moved to Wabeno until a site has been purchased. She had very positive thoughts and ideas about the Fair and offered to help; all that has to be done is someone needs to ask. Al Flannery said there has been nothing on paper from Wabeno. Michelle felt the grounds should be more accessible. Lynne Black would like to meet quarterly to move forward and asked for the meetings to be put on the calendar now.
