#### DISCUSSION AND POSSIBLE ACTION ON ADDITIONAL ACCESS CARD READERS

Sheriff Skallerud explained there was approximately \$120,000 in the Prisoner expenditures account. Skallerud advised the committee that it would cost an additional \$56,000 to have all the doors in the Sheriff's Office outfitted with a card reader system. Motion by Campbell to approve the purchase of the additional card readers, seconded by Piasini. All present voting (AYE). Motion carried. See handouts.

#### DISCUSSION ON ROAD WEIGHT LIMIT VIOLATIONS

Sheriff Skallerud advised the committee that he spoke to the Town Chairman of Popple River recently reference a person hauling hay on town roads that have weight restrictions. Skallerud stated there has been complaints filed in the past and citations issued by Deputies. Skallerud stated the citations have been dismissed because the vehicle was not weighed. Skallerud recommended we escort the vehicle to the Highway Department and used the scale there. Campbell stated he will discuss the issued with Bill Anderson the Highway Commissioner.
