#### **DOT UPDATES**

Kemnitz advised there is currently 9 million dollars of ongoing DOT projects in Forest Co. those projects are the following:

- 1. USH 8 (Oneida County line to Boulevard Avenue) Town of Crandon and City of Crandon
- 2. WIS 32/55 (Crandon RR overhead to Railroad Avenue) City of Crandon and Town of Lincoln
- 3. WIS 32 (Crandon to Three Lakes) Culvert replacements Town of Hiles
- 4. WIS 32 (Oconto County line to County C) Town of Wabeno

Kemnitz advised that all project information is available on the "511WI.goV' website.

Kemnitz advised the Towns of Hiles and Popple River have had some speeding issues or questions. Both towns were provided a copy s.s. 346.57(4) and speed management guidelines in January 2022.

# **B.O.T.S. UPDATES**

Frost advised the committee of the 2022 YTD Forest County crash statistics. There were 85 total crashes in Forest County with 1 fatal crash, 31 injury crashes, and 53 property damage crashes. 33 of the property damage crashes were car versus deer.

#### DISCUSSION ON STATE PATROL AND INSPECTORS IN FOREST COUNTY

Chief Deputy Walrath advised the committee that Forest Co. is expected to get a new Trooper by 2024.

Walrath also advised there have been some weight restriction problems in the Town of Popple River. Walrath advised that is normally handled by Troopers or Inspectors. If the Deputies have to handle that situation, they might have to use the scale at the Highway Dept.

# DISCUSSION ON PROPOSED CONSTRUCTION PROJECT ON HWY 8 EAST

Highway Commissioner Bill Anderson provided a letter to the committee questioning the Highway 8 to Rhinelander project, the reduction of traffic lanes by Pioneer Plaza and east ward, and the narrowing of the northern portion of the intersection of Hwy 8/32/55 in the City of Crandon. The letter was directed to the WI DOT. See letter. Motion by Lucas to file the letter with the minutes of the Traffic Safety Commission meeting, second by Miller. All present voting (AYE). Motion carried.
